**I. *President***, Tom Kashatus called the meeting to order on the above date and time, led those present in the Pledge of Allegiance and proceeded with the order of business.

**II. *Secretary***, Linda Conner read the minutes from the meeting of June 14<sup>th</sup> 2011. Mary Margaret Kashatus made a motion that the minutes with noted corrections be accepted as read and placed on file; seconded by Bill Hourigan, with all voting in favor.

**III.** In the absence of *Treasurer* Francis Zaleski, President Tom Kashatus read and presented the treasurers report from June 14th 2011. Linda Conner made a motion that the report be accepted as read and placed on file; seconded by Faye Maloney, with all voting in favor.

## **IV. *Reading of the Bills & Communication***

- a) The Non-Profit & Community Assistance Center is sponsoring a free workshop entitled, "Finding the Funding and Grant Writing Basics". The event will be held Wednesday, July 13<sup>th</sup> 2011 from 6:00 to 9:00pm at the Electric City Trolley Museum at the Steamtown National Historic Site in Scranton.
- b) The 13<sup>th</sup> Annual Pennsylvania Abandoned Mine Reclamation conference will be held at the Genetti Best Western Lodge in Hazleton on Friday, August 5<sup>th</sup> and Saturday, August 6<sup>th</sup>. NTCO was the recipient of the 2009 (EPCAMR) award from this event. Further discussion has been tabled until a meeting closer to the event date.

## **V. *Reports of Committees***

- a) Membership – Heidi Jarecki will sponsor new member, Olga Yudisky. Mary Margaret Kashatus made a motion to accept; seconded by Mary Jo Evans, with all voting in favor. Palmira Miller will sponsor new member, Jayme Daniele. Linda Conner made a motion to accept; seconded by Bill Hourigan with all voting in favor. Palmira Miller will sponsor new, junior member, Krystal Daniele. Faye Maloney made a motion to accept; seconded by Mary Jo Evans, with all voting in favor. 2011 membership stands at 140 members with 6 junior members.
- b) Recycling – Tom reported that recyclable material is constantly coming in. As the purchase of a 5x10 utility trailer was previously proposed, Tom asked for approval to purchase the trailer from *Tractor Supply* with registration, insurance and miscellaneous fees at a cost not to exceed \$1,500.00. Joe Maloney made a motion to accept; seconded by Carolyn Phillips, with all voting in favor. The trailer will be kept at the Earth Conservancy Compost Center in Newport Township. Tom plans on expressing his appreciation of EC in the upcoming newsletter.
- c) New Business – It was reported that *JD Creations* is no longer on West Kirmar Parkway in Wanamie. Whether the shop moved or had gone out of business was not known.
- d) Great American Clean Up – Coordinator Palmira Miller gave a brief presentation on the revised final report.
- e) Hospitality/Sunshine – Mary Margaret Kashatus made a brief presentation on her suggestions for the contribution policy of the organization towards deceased members. After lengthy discussion, no action was taken.
- f) Editorial – Bill Hourigan and Joe Maloney reported that all ads from the Winter Newsletter seem to be paid in full and that the ads from the Spring Newsletter have all been invoiced. Palmira made a motion for *Waste Management, Waste Reduction and Recycling Enterprises* and *JP Mascaro Inc.* to each receive a free ad in the upcoming newsletter in appreciation of their assistance during the "Great American Clean Up" event; seconded by Stephen Phillips with all voting in favor. Tom stated that he would like to see *Speedy's Auto Body* receive a free ad in appreciation of their material contributions to our recycling program.
