V. Reports of Committees continued

- i) <u>Five Point Plan</u> Mary Margaret Kashatus reported that the 5-Point plan had evolved to the 8-Point plan as eight suggestions were decided upon. These are as follows: 1] STRICT CODE ENFORCEMENT IN ALL AREAS OF THE TOWNSHIP, 2] CREATE AN EMPOWERED RECREATION BOARD WITH THE ABILITY TO RAISE FUNDS AND HAVE A BUDGET, 3] HIRE A GRANT WRITER, 4] SET UP A DISCOUNT PROGRAM FOR SENIOR CITIZENS WITH REGARDS TO THE WASTE REMOVAL & RECYCLING FEE, 5] ENCOURAGE PROSPECTIVE DEVELOPERS OF LAND AND BUILDINGS TO REDEVELOP AREAS WITHIN NEWPORT TOWNSHIP, 6] INSTALL PEDESTRIAN CROSSING SIGNS AT ALL SCHOOL BUS STOPS TO SLOW DOWN TRAFFIC ESPECIALLY DURING THE SCHOOL YEAR, 7] ENCOURAGE THE EMPLOYMENT OF A CAMERA SYSTEM TO MONITOR ILLEGAL DUMPING FOR THE ELIMINATION OF ILLEGAL DUMP SITES THROUGHTOUT NEWPORT TOWNSHIP, 8] ENCOURGAGE MORE EFFECTIVE METHODS OF TRACKING ABSENTEE LANDLORDS TO ENSURE THAT THEY FOLLOW ALL LAWS WITHIN THEIR RESPONSIBILITY. A lengthy discussion on the points with clarifications was held after the presentation. Tom would like to have the plan formalized for presentation to the Newport Township Commissioners in December and publication in the Winter 2011 Newsletter. John Jarecki offered to do the write-up of the plan for presentation.
- j) <u>Nominating Committee</u> Tom announced that NTCO elections would be held at the meeting of November 8th 2011. Anyone with interest in becoming an Officer or member to the Board of Directors is asked to make his or her intentions known.

VI. Unfinished Old Business ("Unfinished" items with new discussion only)

- a) Linda Conner stated that the tee shirts and hoodies would be complete and on hand for the next meeting. She made a motion for a check to be written in the amount of \$645.00 to *Old Newport Decal Screen Printing* for payment upon pick-up of the order; Heidi Jarecki seconded, with all voting in favor.
- b) Palmira Miller gave a brief summary of the flea market held by the South Valley Chamber of Commerce on Saturday, October 8th 2011. She and a few of her family members had painted pumpkins to sell at the event. The ones leftover can be purchased a cost of \$5.00 each with all proceeds to go to the Newport Township Community Organization.
- c) There was a brief discussion on the offer made by CRAZY RABBIT PAINTBALL that would allow for a fundraising opportunity to be had for non-profit organizations at the Harvest Festival they are hosting the weekend of November 12th/13th 2011. Tom stated that NTCO might possibly partner with the Newport Township Consolidated Fire Dept. and split the proceeds. It was previously announced that a donation of \$2.00 per car for parking would be kept by the participating organizations in return for parking assistance and cleaning of the parking areas after the event.

VII. New Business

- a) Tom Kashatus reported that he will need assistance delivering 12 sheets of sheetrock donated by Cathy Gregory Goliash to the Mocanaqua flood shelter where there are 3 refrigerators awaiting pick-up. Anyone that can help is asked to contact Tom.
- b) Tom Kashatus reported that \$100.00 had been given to NTCO by John Jagodzinski with \$10.00 going towards membership dues and \$90.00 to be donated towards the flood relief effort. After some discussion, Faye Maloney made a motion that the \$90.00 be used to purchase building material that will be given to the *Shickshinny Historical Society*; seconded by Mary Margaret Kashatus, with all voting in favor. Tom will handle the purchase and delivery of the items.
- c) A few drafts of a logo for the Newport Township Community Organization were passed around for viewing. The one with the most votes was chosen as the new logo for official use by the organization. Cathy Gregory Goliash was given credit for the winning logo with drafting and development by Stephanie Evans.
- d) The clean up of West Kirmar Avenue as part of the NTCO obligation to the *Adopt-a-Highway Program* has been tentatively scheduled for Saturday, November 5th 2011.
