**I. President.** In the absence of President Palmira Gregory Miller, 1<sup>st</sup> Vice President Tom Kashatus called the meeting to order on the above date and time. In the absence of a quorum, Francis Zaleski made a motion to continue the meeting with eight (8) members present, seconded by Faye Maloney, with all voting in favor. The *Pledge of Allegiance* was then recited and the order of business proceeded upon.

**II. Secretary.** In the absence of Secretary Linda Conner, Tom Kashatus recorded the minutes from the meeting of June 26<sup>th</sup> 2012 and presented them for approval. Mary Jo Evans made a motion that the minutes be accepted as read and placed on file, seconded by Heidi Jarecki, with all voting in favor.

**III. Treasurer** Francis Zaleski presented the treasurers report for July 10<sup>th</sup> 2012. Heidi Jarecki made a motion that the treasurers' report be accepted as read and placed on file, seconded by Faye Maloney, with all voting in favor.

## IV. Reading of the Bills & Communications

- a) Tom Kashatus presented his letter in reply to the initiative of *Casey Dental* "to establish a foundation to fill a void and financially assist individuals with intellectual disabilities with their dental care", in which he proposed to volunteer some of his time collecting scrap metal for reimbursement with the proceeds to be given to the *Casey Dental Foundation*. This endeavor, which will utilize volunteers and equipment from NTCO, was previously approved by the organization.
- b) An invoice from *Blasi Printing Company*, in the amount of **\$1,259.28** for the printing of the summer newsletter was presented for payment. Francis Zaleski made a motion to pay the invoice in full, seconded by Mary Jo Evans, with all voting in favor. It was reported that, due to an error by the printer, 132 extra copies of the newsletter were printed and given to the organization at no extra cost.
- c) A donation of **\$25.00** was received from the *Glen Lyon IASC (Italian Club)* for the annual Memorial Weekend Bazaar.
- d) A letter was received from the *Glen Lyon Crime Watch* announcing their "**National Night Out**" scheduled for Tuesday, August 7<sup>th</sup> 2012 from 5:00 to 8:00pm at the Wanamie Recreation Park. A donation of **\$100.00** from NTCO towards this event was approved at a previous meeting.
- e) A letter was received from the *YMCA* acknowledging the monetary gift made in the memory of the late Evelyn Roke.
- f) A card was received by the family of the late Evelyn Roke in appreciation of the donation made in her memory.
- g) An email was received from Victoria Frace announcing that the *Saint Faustina Parish* in Nanticoke will be hosting men receiving shelter from *Mother Teresa's Haven*. Vicki asked if NTCO would be interested in providing a meal.
- h) An email was received from former Newport Township resident, Corey Zdanavage thanking NTCO for "making a positive difference throughout the community". Corey went on to say that enjoys the newsletters and never misses a publication.
- i) An email by 1<sup>st</sup> Vice President Tom Kashatus was sent to NTCO members and friends providing a link to receive the newsletter in PDF. This is especially relevant to those whose servers will not accept the newsletter as being too large.
