**I. President,** Palmira Gregory Miller called the meeting to order on the above date and time and led those present in reciting the *Pledge of Allegiance*. Prior to proceeding with the order of business, 1<sup>st</sup> Vice President Tom Kashatus introduced guest attendees, Ken Marquis and Trish Gallagher. Mr. Marquis spoke of his purchase of, renovation of and plans for the properties at 59 East Main Street, 61-63 East Main Street and 73 Spring Street in Glen Lyon. Where he was able, Mr. Marquis hired local contractors to perform the work and will continue to do so. The residential property on Spring Street is now ready for occupancy. The East Main Street properties will feature storefront rentals on the first floors with residential apartments on the second floors. Paul and Heidi Jarecki stated their interest in interviewing Mr. Marquis for the upcoming newsletter and provide further details of the investment Mr. Marquis is making in Newport Twp.

### V. *Reports of Committees continued*

- k) Adopt-A-Highway – Palmira Miller reported that 13 volunteers were on hand to pick up debris from Kirmar Parkway in Newport Township. A total of 33 hours were worked and netted 40 bags of trash.

### VII. *New Business*

- a) The scheduling and venue of the NTCO Annual Year end Dinner Meeting was discussed. Linda Conner will contact the *Alden Manor Complex* on availability and price. Francis Zaleski stated that since the meeting of 2011 was held at the *Alden Manor*, he would contact *Maps' Restaurant* in Nanticoke on availability for a change of venue. Both will report at the next meeting.
- b) It was reported that a rumor has been circulating regarding the resignation of Jim Evans as the recently appointed *Acting Chief* for the *Newport Township Police Department*. If this is true or to what possible reasons there could be for the change was not known.
- c) Teena Wrubel asked what action was taken on a recent report of illegal dumping in the Polander Hill area of Newport Township when roofing shingles were found behind Saint Vladimir's Cemetery, an area that was cleaned up as part of an illegal dumpsite cleanup partnership between NTCO and *Pennsylvania Environmental Council* two years ago. Palmira Miller stated that both she and Tom Kashatus were notified about the dumping and informed the municipality of the incident. Earlier that day the *Newport Township Police* was notified of a home in the area undergoing renovation without a permit and the shingles were traced back to the homeowner, who stated that his son was supposed to properly dispose of the debris. The homeowner was told by police to clean up the area or he would be cited. There was a brief discussion on the possibility of "No Dumping" signs being posted, as well as what position the Newport Township Commissioners take on such matters.
- d) It was reminded that the *Newport Township Board of Commissioners* would hold their monthly meeting on Monday, November 5<sup>th</sup> 2012 at 6:00pm in the municipal building in Wanamie.
- e) It was reminded that Tuesday, November 6<sup>th</sup> 2012 is **Election Day** and everyone should get out and vote.

### VIII. *For the Good of the Organization*

- a) Maintenance of memorial tree at the Wanamie Recreation Park is the responsibility of all members.
- b) The president of the organization will always ask for a complete report and cost analysis for projects involving income and expense as a measure of accountability.
