- **I.** *President*, Palmira Gregory Miller called the meeting to order on the above date and time, led those present in the recital of the *Pledge of Allegiance* and proceeded with the order of business.

IV. Reading of the Bills & Communications

It was reported that while Palmira had a work crew, she also used the opportunity to have various roads in the township cleared of debris. Tom stated that the work Palmira is doing with *Pennsylvania Environmental Council* is to be applauded.
- b) Francis Zaleski submitted an "out of pocket" expense of \$20.44 for office supplies. Tom Kashatus made a motion that the amount be paid in full, seconded by Bill Hourigan, with all voting in favor.
- c) Heidi Jarecki submitted an invoice from *Davis Trophies & Plaques* in the amount of \$88.00 for the citizenship award. Tom Kashatus made a motion that the invoice be paid in full, seconded by Joe Maloney, with all voting in favor.
- d) Heidi Jarecki submitted an invoice from *The Cats' Meow Inc*. in the amount of \$201.75 for NTCO memorabilia, stock items. Joe Maloney made a motion that the invoice be paid in full, seconded by Paul Jarecki, with all voting in favor.
- e) A letter was received from the *Pennsylvania Department of Environmental Protection* to confirm that our letter in support of a grant application submitted by *Earth Conservancy Inc.* for reclamation of two land parcels in the area of the former Bliss Colliery in Alden has been received and noted.
- f) A letter was received from *Pennsylvania Environmental Council* in appreciation of the lunch that was provided to volunteers participating in the clean-up event of October 13th 2012.
- g) It was reminded that the *Nanticoke Basketball Booster Club* had set a response date of November 23rd 2012 for advertisements in the 2013 Trojan & Trojanette Program book. Tom Kashatus made a motion to pay \$50.00 for a half page ad, seconded by Linda Conner, with all voting in favor.
- h) An announcement was received from the *Pennsylvania Environmental Council* asking for volunteers in a clean-up event to be held at Chick's Lane in Nescopeck on Saturday, December 1st 2012.
- i) A letter was received from former township resident, Martin "Mitch" Tullai regarding the newsletter generally and our article of the Newport Township football team particularly. Heidi Jarecki stated that the letter was very informative and would be published in its' entirety in the winter newsletter. Mr. Tullai also graciously provided copies of his book, "Football's Best: Quips, Quotes & Quellers" as a gift for the officers of the organization.

V. Reports of Committees

- a) Membership Tom Kashatus reported that there are currently 130 members.
- b) Fundraising Heidi Jarecki reported that the amount of orders increased with the holiday season and that she and Paul created a form to be used at the *Variety Stop* in Glen Lyon to keep track of orders received on site. There was a brief discussion on the fifth miniature in the Newport Township historic site commemorative memorabilia with Lee as the featured town.
