**I. President,** Palmira Gregory Miller called the meeting to order on the above date and time, led those present in the recital of the *Pledge of Allegiance* and proceeded with the order of business.

**II. Secretary,** Linda Conner read the minutes from the previous meeting of November 12<sup>th</sup> 2013. Debbie Prokop made a motion that the minutes with noted corrections be accepted as read and placed on file, seconded by Tom Kashatus, with all voting in favor.

## IV. Reading of the Bills & Communications

- a) A copy of an invoice in the amount of \$2,770.00 was received from *Newport Township Authority* for the monies paid towards "soft costs" in the demolition of the structure at 85 East Main Street Glen Lyon. Palmira Miller provided a break down of the invoice and it was submitted to the treasurer. The organization had agreed to contribute \$2,000.00 towards "soft cost" expenses incurred by the authority for this project.
- b) An out-of-pocket expense was incurred by Paul Jarecki for purchase and engraving of the Citizenship Award. Because Paul did have the invoice to submit and was unsure of the exact amount, a motion was made by Tom Kashatus to reimburse in an amount not to exceed \$50.00, seconded by Steven Dymond, with all voting in favor.
- c) An announcement was received from *Saint Nicholas' Ukrainian Catholic Church* in Glen Lyon regarding their Clam Chowder & Haluski Sale. Orders will be taken until December 3<sup>rd</sup> 2013 with pick-up at the church on Thursday, December 12<sup>th</sup>.
- d) An email was received from *The 2014 Garnier Green Garden Campaign* with an opportunity for five, non-profit community organizations to receive a community garden. Nominations must be submitted by December 15<sup>th</sup> 2013.
- e) Tom Kashatus received a verbal communication from Mike Yalch regarding the live, Christmas manger pageant to be held by *Saint Faustina's Parish* at the Holy Child Grove in Sheatown on Friday, December 6<sup>th</sup> and Saturday, December 7<sup>th</sup> 2013. Community involvement is encouraged.
